TITLE THREE Collectors' duties

Art. 11- The authorized collectors pay to the cereals office:

1- the statistical tax fixed by article 6 of this decree which shall be paid out of the price paid by the producers,

2- per quintal of returned hard wheat, tender wheat, barely and triticale and after payment out of the retrocession margin included into the retrocession normal prices, as provided for in article 8 of this decree:

a- an amount intended to cover the bonus provided for in article 12 of this decree fixed as follow:

- hard wheat: 3.133 D/ ql
- tender wheat: 2.700 D/ql
- barley: 2.478 D/ql
- triticale: 2.478 D/ql

However, it may be possible to adjust this amount by an order of the Minister of Agriculture and Water Resources, when the retention of the collected cereals for a period exceeding six months is deemed necessary, on a submission of a detailed statement indicating the existing stocks in the concerned institutions.

b- an amount of 0.100 D assigned to the account of the budget of the cereals office, untitled "equipment fund of the cereals office".

3- per quintal of hard wheat and tender wheat, delivered directly from the farming to the semolina factories and the flour milling, an amount of 0.075 D/ql to be paid out of the retrocession margin and assigned to the account of the budget of the cereals office, untitled "equipment fund of the cereals office".

Art. 12- The collecting and stocking institutions benefit from a warehousing bonus intended to cover the fees of financing, keeping and conservation of the cereals of the harvest 2008.

The monthly rate of the warehousing bonus is fixed as follow:

- hard wheat: 0.522D/ ql
- tender wheat: 0.450 D/ql
- barley: 0.413 D/ql
- triticale: 0.413 D/ql

This bimonthly bonus is computed on the basis of stocks to the warehouse at the end of the day, the 15 and the last day of each month.

The settlement methods of the warehousing bonus are fixed in annex II of this decree (*).

Art. 13- The collecting and stocking institutions, which deliver wheat, barley and triticale of the harvest 2008 to the retrocession price reduced according to the provisions of article 9 and 10, receive a compensating bonus as determined by article 14 of this decree.

Art. 14- The amount of the compensating bonus assigned to the general fund of compensation, is fixed for each produce as the difference between the retrocession normal prices as fixed by article 8 of this decree, and the reduced retrocession prices as fixed by a decision of the Minister of trade and handicrafts after an adjustment of these prices, by the schedule of scaling to the purchase and sale.

Art. 15- The amounts of warehousing bonus provided in article 12 of this decree as well as the differences of scale, are assigned to the account of the budget of the cereals office, untitled "equipment fund of the cereals office".

Art. 16- The Minister of Finance, the Minister of Agriculture and Water Resources, the Minister of Trade and Handicrafts and the Minister of Development and International Cooperation, each in his respective capacity, shall implement this decree which shall be published in the Official Gazette of the Republic of Tunisia.
