# Mock: Collecting regional comments

## SCENARIO:

- => December: An EWG has produced draft text on 'Growing media'...
- => May: SC has sent for first round of Member consultation...
- => July: Individual countries have scrutinized text and noted comments...
- => September: Some regions each decided to collect, discuss and submit joint comments from each their region to SC-7...
- => You are now in that regional meeting to discuss with other countries of your region

## Mock: Collecting regional comments

### **SIMULATION: *Before workshop:***

Each participant = 1 fictive 'country':

#### ***To do:***

Read text, contemplate on content and wording, and *individually* produce 3 comments on 3 problematic text parts. In each comment, state:

Where in text ?

What is wrong ?

Why is it wrong ?

Suggestion for change of text !

Send to OPERA

## Mock: Collecting regional comments

### **SIMULATION: *At workshop:***

Each participant = 1 fictive 'country'.

Ca. 7 participants form one fictive 'region'

Input: ca.  $7 \times 3 = 21$  comments

### ***To do together per 'region':***

Read (10 min.) all comments from region [as sent from OPERA]

Select a 'regional steward' (to finalize regional output)

Discuss all comments

Select 5 comments, refine text proposal and explanation

Hand over 5 comments to OPERA
