SCENARIO:

=> October: SC-7 has received members comments...

=> May: SC-7 meeting to

- ✓ discuss all comments in order to provide improved version of draft ISPM for 2nd round of member consultation
- ✓ select appropriate comments and refine text proposal
- ✓ explain its opinion on all comments

=> You are now in an SC-7 meeting

Mock: SC-7 discusses comments

SIMULATION:

Each participant = 1 SC-7 member

Ca. 7 participants form one fictive SC-7

Input: $5 \times 3 = 15$ comments

To do together per 'SC-7':

Select a 'global steward'

Select a chairperson

Read individually (20 min.) all 15 comments [as handed out from OPERA]

Mock: SC-7 discusses comments (cont'd)

SIMULATION (cont'd: *To do together per 'SC-7'*):

Global steward presents an overview of major comments

Global steward presents and provide her/his opinion on each comment at a time, followed by Group discussion. For each comment, the Group:

- ✓ agrees whether to accept comment, and how to possibly refine the text proposal
- ✓ provide explanation for comments not taken or if altered

Group hands over to OPERA 15 comments-with comments
