Description of task(s) and objectives to be achieved (per mission if applicable)

Under the general supervision of the NEPPO Secretariat and in collaboration the RPW working Group, the consultant will perform the following tasks:

- 1. A regional standard for harmonized phytosanitary measures within the region (at borders and inspection on the territory) is drafted
 - 1.1 Develop a questionnaire to assess the effectiveness of the phytosanitary regulations and measures related to Red Palm weevil applied by countries and their compliance with the international standards for phytosanitary measures (ISPMs) and other regionally recognized standards
 - 1.2 Launch the questionnaire to NENA Countries
 - 1.3 Analyze and assess the information gathered, scoping studies, technical situational reports, guidelines and training materials on palm trees (date palm and ornamentals inspection at borders)
 - 1.4 Develop the draft regional standard for phytosanitary measures on RPW
 - 1.5 Organize and convene virtual meetings of the RPW working group experts as necessary, including
 preparing the agenda, ensuring experts are contributing, preparing and posting all meeting documents on
 time, preparing the minutes and facilitating the gathering and coordinating of the development of related
 standards and training materials.
 - 1.6 Gather suggestions and observations of core group and countries and update the standard accordingly
 - 1.7 Prepare guidelines and training materials on this standard
 - 1.8 Supervise the translation of the adopted version in Arabic
